Annual Report of Drug Testing by Middlesex County Law Enforcement

- Applicant testing for sworn law enforcement officer positions is required once a conditional offer of employment has been made
- Reasonable Suspicion Drug Testing is to occur as required
- Random Drug Testing must occur on a semi-annual basis, split into 2 test cycles each calendar year
- A minimum of 10% of the sworn law enforcement officers employed by the agency are to be randomly tested in each test cycle
- Notification to the Central Drug Registry is required when an applicant and/or sworn law enforcement officer tests positive or refuses to be tested.
- This annual report must be submitted to the MCPO no later than 15 January for each agency's drug testing activities from the prior calendar year
