## Annual Report of Drug Testing by Middlesex County Law Enforcement

- Applicant testing for sworn law enforcement officer positions is required once a conditional offer of employment has been made
- Reasonable Suspicion Drug Testing is to occur as required
- Random Drug Testing must occur on a semi-annual basis, split into 2 test cycles each calendar year
- A minimum of 10% of the sworn law enforcement officers employed by the agency are to be randomly tested in each test cycle
- Notification to the Central Drug Registry is required when an applicant and/or sworn law enforcement officer tests positive or refuses to be tested.
   This annual report must be submitted to the MCPO no later than 15 January for each agency's drug testing activities from the prior calendar year
